AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 4) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Kelantan, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 4) 2014**.

(2) Perintah ini mula berkuat kuasa pada 28 Februari 2014.

Pindaan Jadual Ketiga

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Ketiga di bawah kepala “Negeri Kelantan Darul Naim”—

(a) dengan memasukkan selepas butiran 2 butiran yang berikut:

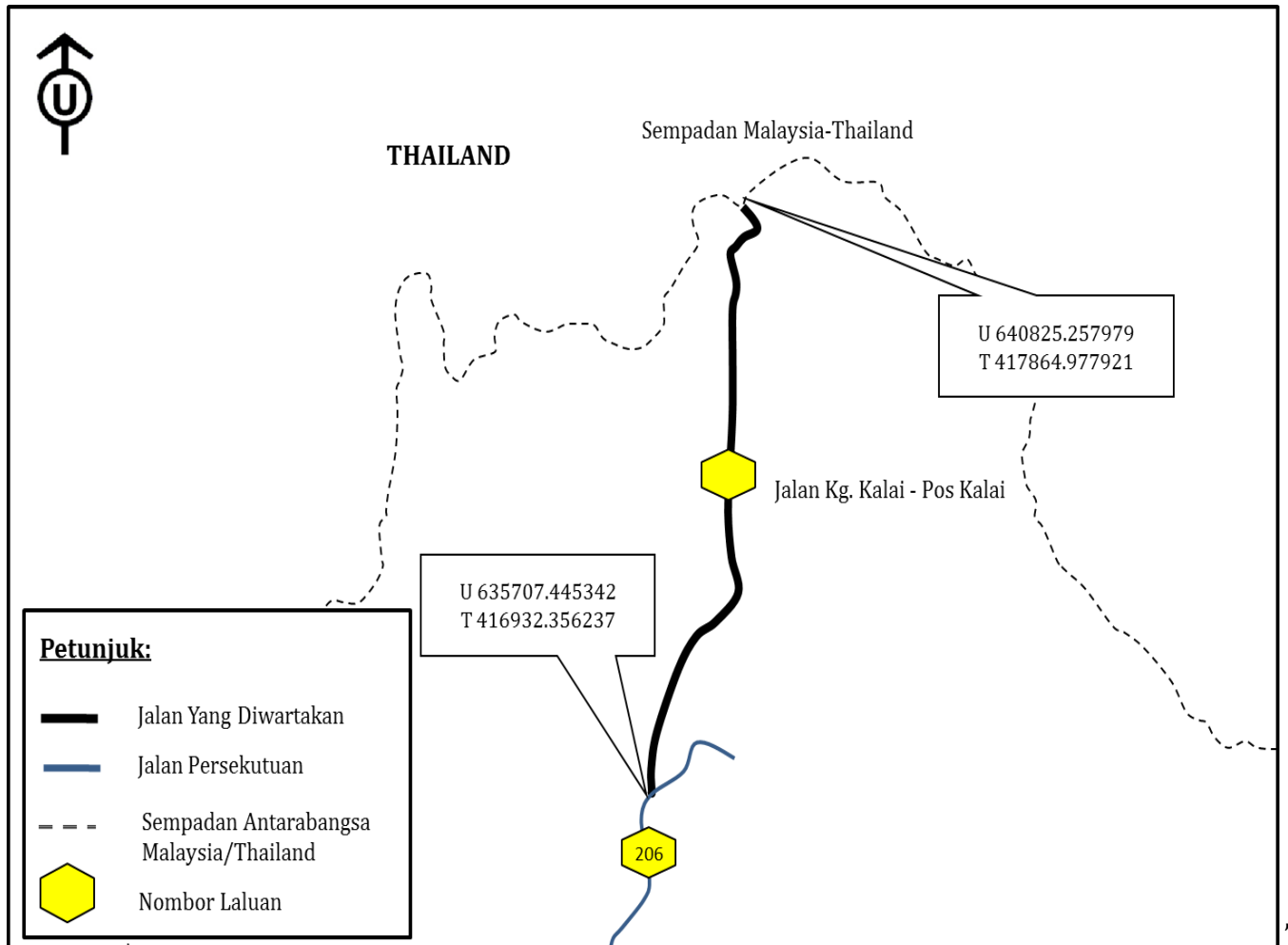
“3. *(Laluan 481): Jalan Kg. Kalai–Pos Kalai, Jeli*

Dari persimpangannya dengan Laluan 206, Jalan Batu Melintang-Kalai di koordinat U635707.445342, T416932.356237 dan berakhir di sempadan Malaysia-Thailand di koordinat U640825.257979, T417864.977921 sebagaimana yang ditunjukkan dalam Peta 3: Jalan Kg. Kalai-Pos Kalai, Jeli.

Jarak sepanjang 5.6 km.”; dan

(b) dengan memasukkan selepas PETA 2: JALAN-JALAN PERSEKUTUAN NEGERI KELANTAN peta yang berikut:

“PETA 3: JALAN KG. KALAI-POS KALAI, JELI

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 4) ORDER 2014

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Kelantan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 4) Order 2014**.

(2) This Order comes into operation on 28 February 2014.

Amendment of Third Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the Third Schedule under the heading “Negeri Kelantan Darul Naim”—

(a) by inserting after item 2 the following item:

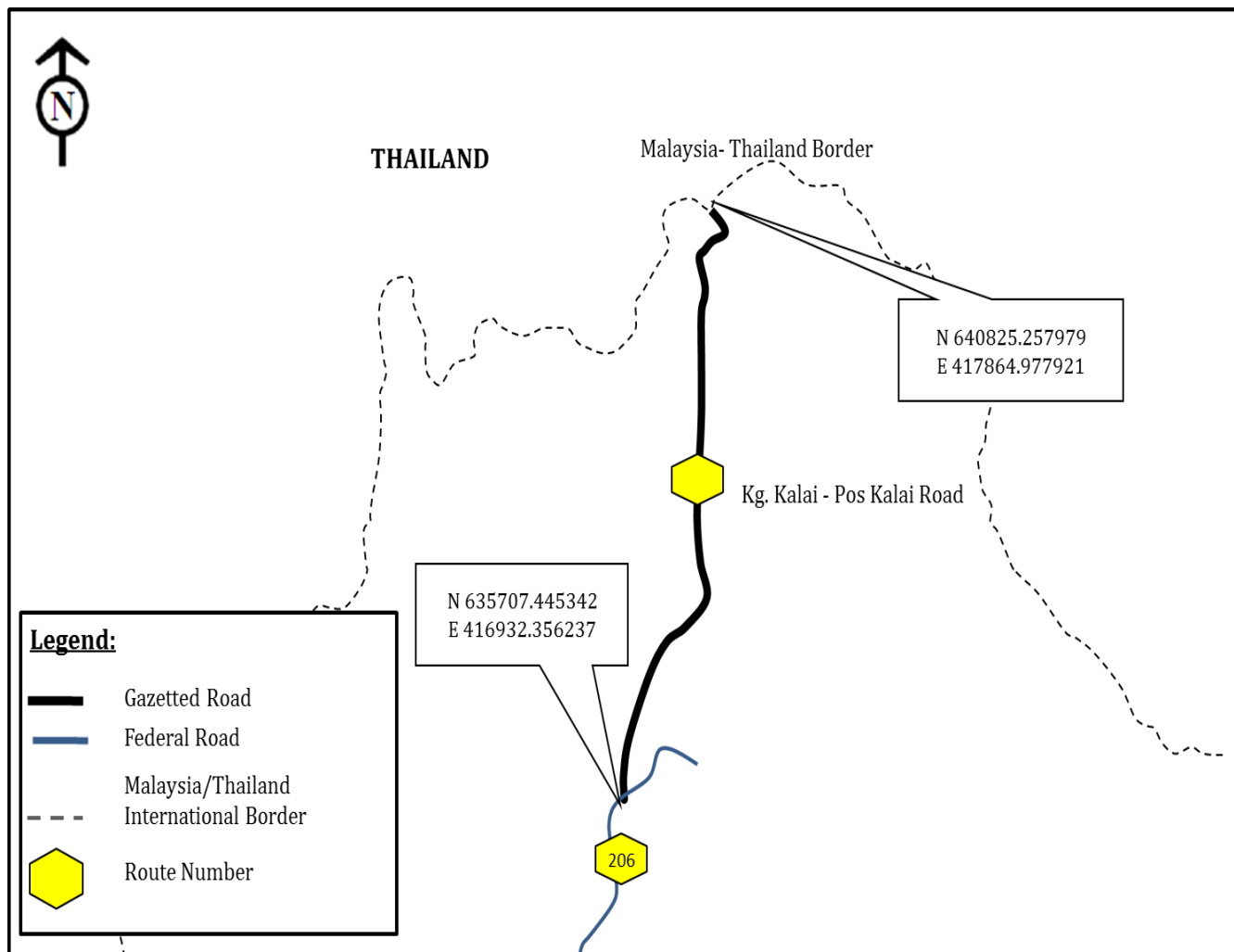
“3. *(Route 481): Kg. Kalai-Pos Kalai Road, Jeli*

From its junction with Route 206, Batu Melintang-Kalai Road at coordinates N635707.445342, E416932.356237 and ending at the Malaysia-Thailand border at coordinates N640825.257979, E417864.977921 as shown on Map 3: Kg. Kalai-Pos Kalai Road, Jeli.

A distance of 5.6 km.”; and

(b) by inserting after MAP 2: FEDERAL ROADS OF NEGERI KELANTAN the following map:

“MAP 3: KG. KALAI-POS KALAI ROAD, JELI
