## AKTA KASTAM 1967

## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) 2014**.

(2) Perintah ini mula berkuat kuasa pada 27 Januari 2014.

**Pindaan Jadual Ketiga**

2. Perintah Kastam (Larangan Mengenai Import) 2012 [P.U. (A) 490/2012] dipinda dalam Bahagian I Jadual Ketiga dengan memasukkan selepas butiran 63 dan butir-butir yang berhubungan dengannya butiran yang berikut:

## CUSTOMS ACT 1967

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2014

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2014**.

(2) This Order comes into operation on 27 January 2014.

**Amendment of Third Schedule**

2. The Customs (Prohibition of Imports) Order 2012 [*P.U. (A) 490/2012*] is amended in Part I of the Third Schedule by inserting after item 63 and the particulars relating to it the following items:
