ENTERTAINMENTS DUTY ACT 1953

ENTERTAINMENTS DUTY (EXEMPTION FOR THEME PARKS)
(REVOCATION) ORDER 2013

IN exercise of the powers conferred by subsection 12(1) of the Entertainments Duty Act 1953 [*Act 103*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Entertainments Duty (Exemption for Theme Parks) (Revocation) Order 2013**.

(2) This Order comes into operation on 2 January 2014.

Revocation

2. The Entertainments Duty (Exemption for Theme Parks) Order 2005 [*P.U. (A) 509/2005*] is revoked.
