CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 6) ORDER 2013

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

Citation

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 6) Order 2013**.

Controlled articles

2. The articles specified in the Schedule are declared to be controlled articles for the period from 23 December 2013 to 27 December 2013.

SCHEDULE

CONTROLLED ARTICLES

1. Local bone-in mutton
2. Imported bone-in mutton
3. Imported boneless mutton (not including leg)
4. Imported bone-in mutton leg
5. Tomato
6. Green pepper (capsicum)
