## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 5) 2013

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 5) 2013**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2014.

## CUSTOMS ACT 1967

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 5) ORDER 2013

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 5) Order 2013**.

(2) This Order comes into operation on 1 January 2014.

**Amendment of Second Schedule**

2. The Customs (Prohibition of Imports) Order 2012 [*P. U. (A) 490/2012*] is amended in Part I of the Second Schedule by inserting after item 8 and the particulars relating to it the following item:
