PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 4) 2013

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 4) 2013**.

(2) Perintah ini mula berkuat kuasa pada 15 Januari 2014.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 4) ORDER 2013

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 4) Order 2013**.

(2) This Order comes into operation on 15 January 2014.

Amendment of Third Schedule

2. The Customs (Prohibition of Imports) Order 2012 [*P.U. (A) 490/2012*] is amended in Part I of the Third Schedule by inserting after item 62 and the particulars relating to it the following item:
