PERINTAH KAWALAN BEKALAN (BARANG-BARANG KAWALAN) (NO. 5) 2013

PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Kawalan Bekalan 1961 [Akta 122], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Barang-Barang Kawalan) (No. 5) 2013**.

(2) Perintah ini mula berkuat kuasa pada 28 Oktober 2013.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 5) ORDER 2013

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [Act 122], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Control of Supplies (Controlled Articles) (No. 5) Order 2013**.

(2) This Order comes into operation on 28 October 2013.

Controlled articles

2. The articles specified in the Schedule are declared to be controlled articles for the period from 28 October 2013 to 6 November 2013.
