MEDICAL ACT 1971

MEDICAL (AMENDMENT OF SECOND SCHEDULE) (NO. 3) ORDER 2013

IN exercise of the powers conferred by subsection 12(2) of the Medical Act 1971 [Act 50], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Medical (Amendment of Second Schedule) (No. 3) Order 2013**.

Amendment of Second Schedule

2. The Medical Act 1971 is amended in the Second Schedule in relation to the country of "India" by inserting the following items:

<i>Name of Institution granting qualification</i>	<i>Description of qualification</i>
"S. S. Institute of Medical Sciences & Research Centre (SSIMSRC)	Bachelor of Medicine and Bachelor of Surgery (Recognised on 12 July 2012)".
