ROAD TRANSPORT (FEE FOR REMOVAL AND DETENTION OF MOTOR VEHICLES)
(REVOCATION) RULES 2013

IN exercise of the powers conferred by subsection 65(7) of the Road Transport Act 1987 [Act 333], the Commissioner of the City of Kuala Lumpur, after consultation with the Minister, makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Road Transport (Fee for Removal and Detention of Motor Vehicles) (Revocation) Rules 2013**.

(2) These Rules come into operation on 1 October 2013.

Revocation

2. The City of Kuala Lumpur (Motor Vehicle Removal and Detention Fees) Rules 1977 [*P.U. (A) 25/1977*] are revoked.
