Pindaan Jadual Kelima

2. Kaedah-Kaedah Kenderaan Motor (Pengangkutan Perdagangan) 1959 [*L.N. 175/1959*] dipinda dalam Jadual Kelima di bawah kepala "PART 1 – WEST MALAYSIA" berhubung dengan subkepala "FARES AND RATES TO BE CHARGED"—

(a) dengan menggantikan butiran 11 dengan butiran yang berikut:

"11. The rates to be charged for the carriage of goods for hire and reward shall be as mutually agreed between the parties."; dan

LAND PUBLIC TRANSPORT ACT 2010

LAND PUBLIC TRANSPORT [MOTOR VEHICLES (COMMERCIAL TRANSPORT)
(AMENDMENT) RULES 2013] REGULATIONS 2013

IN exercise of the powers conferred by paragraph 252(1)(s) of the Land Public Transport Act 2010 [Act 715], on the recommendation of the Commission, the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Land Public Transport [Motor Vehicles (Commercial Transport) (Amendment) Rules 2013] Regulations 2013**.

Amendment of Fifth Schedule

2. The Motor Vehicles (Commercial Transport) Rules 1959 [L.N. 175/1959] are amended in the Fifth Schedule under the heading “PART 1 – WEST MALAYSIA” in relation to subheading “FARES AND RATES TO BE CHARGED”—

(a) by substituting for item 11 the following item:

“11. The rates to be charged for the carriage of goods for hire and reward shall be as mutually agreed between the parties.”; and

(b) by substituting for subitem 12(j) the following subitem:
