EXCISE DUTIES (AMENDMENT) ORDER 2013

IN exercise of the powers conferred by subsection 6(1) of the Excise Act 1976 [Act 176], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Excise Duties (Amendment) Order 2013**.
- (2) This Order comes into operation on 27 September 2013.
