PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Ahli Sabah Society For The Blind) 2013**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 22 Ogos 2013.

Penepian fi

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam butiran 3(a)(ii) Jadual kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Cai) 2006 [*P.U. (A) 409/2006*] diketepikan berkenaan dengan seseorang ahli Sabah Society For The Blind yang memohon bagi pengiktirafan pencapaian kemahiran terdahulu yang membawa kepada anugerah Sijil Kemahiran Malaysia.

(2) Penepian fi di bawah subperaturan (1) terpakai bagi pengiktirafan pencapaian kemahiran terdahulu yang berhubung dengan refleksologi kaki, tangan dan telinga, atau urut terapi, yang memenuhi kehendak Standard berkaitan.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT (WAIVER OF FEE TO MEMBER OF SABAH SOCIETY FOR THE BLIND) REGULATIONS 2013

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Member of Sabah Society For The Blind) Regulations 2013**.

(2) These Regulations come into operation on 22 August 2013.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in item 3(a)(ii) of the Schedule to the National Skills Development (Fees and Charges) Regulations 2006 [P.U. (A) 409/2006] is waived in respect of a member of the Sabah Society For The Blind who applies for the recognition of prior skills achievement leading to the award of the Malaysian Skills Certificate.

(2) The waiver of fee under subregulation (1) is applicable for the recognition of prior skills achievement in relation to foot, hand and ear reflexology, or massage therapy, which satisfies the requirements of the relevant Standards.
