AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) 2013

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) 2013**.

(2) Perintah ini mula berkuat kuasa pada 5 Ogos 2013.

Pindaan Jadual Ketiga

2. Perintah Kastam (Larangan Mengenai Import) 2012 [*P.U. (A) 490/2012*] dipinda dalam Bahagian 1 Jadual Ketiga dengan memasukkan selepas butiran 60 dan butir-butir yang berhubungan dengannya butiran yang berikut:

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2013

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2013**.

(2) This Order comes into operation on 5 August 2013.

Amendment of Third Schedule

2. The Customs (Prohibition of Imports) Order 2012 [*P.U. (A) 490/2012*] is amended in Part 1 of the Third Schedule by inserting after item 60 and the particulars relating to it the following item:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Chapter/Heading/ Subheading</i>	(4) <i>Country</i>	(5) <i>Manner of Import</i>
"61.	Semi-finished printed bank notes which are not yet legal tender either in the country of issue or elsewhere	4907.00 900	All countries	That the import is accompanied by a letter of approval issued by or on behalf of the Minister of Home Affairs".
