PERATURAN-PERATURAN KAEDAH-KAEDAH PELAJARAN (KINDERGARTEN DAN SEKOLAH ASUHAN) (PENDAFTARAN) (PINDAAN) 2013

PADA menjalankan kuasa yang diberikan oleh perenggan 130(2)(e), (f), (q), (r) dan (s) Akta Pendidikan 1996 [*Akta 550*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kaedah-Kaedah Pelajaran (Kindergarten dan Sekolah Asuhan) (Pendaftaran) (Pindaan) 2013**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2013.

**Pemotongan kaedah 17, 18 dan 19**

2. Kaedah-kaedah Pelajaran (Kindergarten dan Sekolah Asuhan) (Pendaftaran) 1972 [*P.U. (A) 414/1972*], yang dalam Peraturan-Peraturan ini disebut “Kaedah-Kaedah ibu”, dipinda dengan memotong kaedah 17, 18 dan 19.

**Pindaan kaedah 21**

3. Kaedah 21 Kaedah-Kaedah ibu dipinda—

(a) dalam nota birai, dengan memotong perkataan “dan permit-permit”; dan

(b) dalam subkaedah (1), dengan memotong perkataan “atau permit untuk mengajar”.

**Pindaan kaedah 22**

4. Kaedah 22 Kaedah-Kaedah ibu dipinda—

(a) dalam nota birai, dengan memotong perkataan “atau permit”;

- (b) dalam subkaedah (1)—
- (i) dengan memotong perkataan “atau kepada pemegang sesuatu permit untuk mengajar”;
  - (ii) dengan memotong perkataan “atau permit gantian untuk mengajar”; dan
  - (iii) dengan memotong perkataan “atau permit untuk mengajar”;
- (c) dalam proviso pertama—
- (i) dengan memotong perkataan “atau permit untuk mengajar”;
  - (ii) dengan memotong perkataan “atau pemegang permit”;
  - (iii) dengan memotong perkataan “atau permit gantian”; dan
  - (iv) dengan memotong perkataan “atau permit”;
- (d) dalam proviso kedua—
- (i) dengan memotong perkataan “atau permit gantian untuk mengajar”; dan
  - (ii) dengan memotong perkataan “atau pemegang permit”;

(e) dalam subkaedah (2)—

- (i) dengan memotong perkataan “atau permit untuk mengajar”;
- (ii) dengan memotong perkataan “atau permit gantian”; dan
- (iii) dengan memotong perkataan “atau permit”; dan

(f) dalam subkaedah (3)—

- (i) dengan memotong perkataan “atau permit gantian untuk mengajar”;
- (ii) dengan memotong perkataan “atau permit mengajar”; dan
- (iii) dengan memotong perkataan “atau permit”.

#### **Pindaan kaedah 24**

5. Kaedah 24 Kaedah-Kaedah ibu dipinda—

(a) dalam perenggan (c)—

- (i) dengan memasukkan selepas perkataan “pengelola” perkataan “atau”; dan
- (ii) dengan memotong perkataan “atau guru”; dan

(b) dalam perenggan (d) dengan memotong perkataan “atau permit gantian”.

EDUCATION ACT 1996

EDUCATION (KINDERGARTEN AND NURSERY SCHOOL) (REGISTRATION) RULES  
REGULATIONS (AMENDMENT) 2013

IN exercise of the powers conferred by paragraphs 130(2)(e), (f), (q), (r) and (s) of the Education Act 1996 [*Act 550*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Education (Kindergarten and Nursery School) (Registration) Rules Regulations (Amendment) 2013**.

(2) These Regulations come into operation on 1 September 2013.

**Deletion of rules 17, 18 and 19**

2. The Education (Kindergarten and Nursery School) (Registration) Rules 1972 [*P.U. (A) 414/1972*], which in these Regulations are referred to as “the principal Rules”, are amended by deleting rules 17, 18 and 19.

**Amendment of rule 21**

3. Rule 21 of the principal Rules is amended—

(a) in the marginal note, by deleting the words “and permits”; and

(b) in subrules (1), by deleting the words “or permit to teach”.

**Amendment of rule 22**

4. Rule 22 of the principal Rules is amended—

(a) in the marginal note, by deleting the words “or permits”;

(b) in subrule (1)—

(i) by deleting the words “or to the holder of a permit to teach”;

- (ii) by deleting the words “or a replacement permit to teach”; and
  - (iii) by deleting the words “or permit to teach”;
- (c) in the first proviso—
- (i) by deleting the words “or permit to teach”;
  - (ii) by deleting the words “or the permit holder”;
  - (iii) by deleting the words “or replacement permit”; and
  - (iv) by deleting the words “or permit”;
- (d) in the second proviso—
- (i) by deleting the words “or replacement permit to teach”; and
  - (ii) by deleting the words “or permit holder”;
- (e) in subrule (2)—
- (i) by deleting the words “or permit to teach”;
  - (ii) by deleting the words “or replacement permit”; and
  - (iii) by deleting the words “or permit”; and
- (f) in subrule (3)—
- (i) by deleting the words “or replacement permit to teach”;

- (ii) by deleting the words “or permit to teach”; and
- (iii) by deleting the words “or permit”.

**Amendment of rule 24**

5. Rule 24 of the principal Rules is amended—

(a) in paragraph (c)—

- (i) by inserting after the word “governor” the word “or”; and
- (ii) by deleting the words “or teacher”; and

(b) in paragraph (d) by deleting the words “or permit”.

**Amendment of Schedule**

6. The Schedule of the principal Rules is amended by deleting Form K.
