AKTA PERKHIDMATAN KEWANGAN ISLAM 2013

PERINTAH PERKHIDMATAN KEWANGAN ISLAM (AMAUN MINIMUM DANA MODAL
ATAU LEBIHAN ASET BERBANDING LIABILITI) (ORANG BERLESEN) 2013

PADA menjalankan kuasa yang diberikan oleh subseksyen 12(1) Akta Perkhidmatan Kewangan Islam 2013 [*Akta 759*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perkhidmatan Kewangan Islam (Amaun Minimum Dana Modal atau Lebihan Aset Berbanding Liabiliti) (Orang Berlesen) 2013**.

(2) Perintah ini mula berkuat kuasa pada 30 Jun 2013.

Pemakaian

2. Perintah ini terpakai bagi orang berlesen.

Tafsiran

3. Dalam Perintah ini—

“pengendali takaful semula profesional asing berlesen” ertinya seorang pengendali takaful semula yang diperbadankan di luar Malaysia yang diberi lesen di bawah seksyen 10 Akta untuk menjalankan perniagaan takaful semula sahaja;

“pengendali takaful semula profesional berlesen” ertinya seorang pengendali takaful semula yang diperbadankan di Malaysia yang diberi lesen di bawah seksyen 10 Akta untuk menjalankan perniagaan takaful semula sahaja.

Dana modal minimum

4. Amaun minimum dana modal bagi orang berlesen yang merupakan suatu syarikat hendaklah mengikut amaun yang ditentukan dalam Jadual 1.

Lebih aset berbanding liabiliti minimum

5. Amaun minimum lebih aset berbanding liabiliti bagi orang berlesen yang merupakan suatu cawangan yang ditubuhkan oleh suatu institusi asing di Malaysia hendaklah mengikut amaun yang ditentukan dalam Jadual 2.

ISLAMIC FINANCIAL SERVICES ACT 2013

ISLAMIC FINANCIAL SERVICES (MINIMUM AMOUNT OF CAPITAL FUNDS OR SURPLUS OF ASSETS OVER LIABILITIES) (LICENSED PERSON) ORDER 2013

IN exercise of the powers conferred by subsection 12(1) of the Islamic Financial Services Act 2013 [Act 759], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Islamic Financial Services (Minimum Amount of Capital Funds or Surplus of Assets Over Liabilities) (Licensed Person) Order 2013**.

(2) This Order comes into operation on 30 June 2013.

Application

2. This Order applies to a licensed person.

Interpretation

3. In this Order—

“licensed foreign professional retakaful operator” means a retakaful operator incorporated outside Malaysia which is licensed under section 10 of the Act to carry on solely retakaful business;

“licensed professional retakaful operator” means a retakaful operator incorporated in Malaysia which is licensed under section 10 of the Act to carry on solely retakaful business.

Minimum capital funds

4. The minimum amount of capital funds of a licensed person which is a company shall be in accordance with the amount specified in Schedule 1.

Minimum surplus of assets over liabilities

5. The minimum amount of surplus of assets over liabilities of a licensed person which is a branch established by a foreign institution in Malaysia shall be in accordance with the amount specified in Schedule 2.
