TAKAFUL ACT 1984

TAKAFUL (SURPLUS OF ASSETS OVER LIABILITIES) (REVOCATION)
REGULATIONS 2013

IN exercise of the powers conferred by section 68 read together with paragraph 4(2)(b) of the Takaful Act 1984 [Act 312], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Takaful (Surplus of Assets Over Liabilities) (Revocation) Regulations 2013**.

(2) These Regulations come into operation on 30 June 2013.

Revocation

2. The Takaful (Surplus of Assets Over Liabilities) Regulations 1985 [P.U. (A) 307/1985] published on 15 July 1985 are revoked.
