EXCHANGE CONTROL ACT 1953

EXCHANGE CONTROL (WHOLESALE CURRENCY BUSINESS) (EXEMPTION)
(REVOCATION) ORDER 2013

IN exercise of the powers conferred by section 34 of the Exchange Control Act 1953 [Act 17], the Controller of Foreign Exchange makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Exchange Control (Wholesale Currency Business) (Exemption) (Revocation) Order 2013**.

(2) This Order comes into operation on 30 June 2013.

Revocation

2. The Exchange Control (Wholesale Currency Business) (Exemption) Order 2011 [P.U. (A) 398/2011] is revoked.
