MEDICAL ACT 1971

MEDICAL (AMENDMENT OF SECOND SCHEDULE) (NO. 2) ORDER 2013

IN exercise of the powers conferred by subsection 12(2) of the Medical Act 1971 [Act 50], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Medical (Amendment of Second Schedule) (No. 2) Order 2013**.

Amendment of Second Schedule

2. The Medical Act 1971 is amended in the Second Schedule by inserting after the item "Ceylon" and the details appearing against it the following item:
