PROMOTION OF INVESTMENTS (DECLARATION OF SHAREHOLDERS' FUNDS IN
RELATION TO A SMALL SCALE COMPANY UNDER SECTION 2) (AMENDMENT)
ORDER 2013

IN exercise of the powers conferred by section 2 of the Promotion of Investments Act 1986 [Act 327], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Promotion of Investments (Declaration Of Shareholders' Funds In Relation To a Small Scale Company Under Section 2) (Amendment) Order 2013**.

(2) This Order is deemed to have come into operation on 3 July 2012.

Amendment of paragraph 2

2. The Promotion of Investments (Declaration Of Shareholders' Funds In Relation To a Small Scale Company Under Section 2) Order 1989 [*P.U. (A) 83/1989*] is amended in paragraph 2 by substituting for the words "five hundred thousand" the words "two million five hundred thousand".
