(PINDAAN) 2013

ROAD TRANSPORT ACT 1987

MOTOR VEHICLES (CONSTRUCTION AND USE) (AMENDMENT) RULES 2013

IN exercise of the powers conferred by section 66 of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Motor Vehicles (Construction and Use) (Amendment) Rules 2013**.

(2) These Rules come into operation on 1 January 2015.

Amendment of Third Schedule

2. The Motor Vehicles (Construction and Use) Rules 1959 [L.N. 170/1959] are amended in the Third Schedule—

(a) by inserting after paragraph 1 the following paragraph:

“1A. UN ECE Regulation 4 Uniform Provisions Concerning the Approval of Devices for the Illumination of Rear Registration Plates of Motor Vehicles (Except Motorcycles) and Their Trailers;”;

(b) by inserting after paragraph 3 the following paragraphs:

“3A. UN ECE Regulation 10 Uniform Provisions Concerning the Approval of Vehicles With Regard to Electromagnetic Compatibility;

3B. UN ECE Regulation 11 Uniform Provisions Concerning the Approval of Vehicles With Regard to Door Latches and Door Retention Components;”;

(c) by inserting after paragraph 7 the following paragraphs:

“7A. UN ECE Regulation 19 Uniform Provisions Concerning the Approval of Motor Vehicles Front Fog Lamps;

(f) by inserting after paragraph 13 the following paragraphs:

13B. UN ECE Regulation 45 Uniform Provisions Concerning the Approval of Headlamps Cleaners and of Power-Driven Vehicles With Regard to Headlamp Cleaners;”;

(g) by inserting after paragraph 18 the following paragraph:

“18A. UN ECE Regulation 55 Uniform Provisions Concerning the Approval of Mechanical Coupling Components of Combinations of Vehicles;”;

(h) by inserting after paragraph 19 the following paragraphs:

“19A. UN ECE Regulation 60 Uniform Provisions Concerning the Approval of Two-Wheeled Motorcycles and Mopeds With Regard to Driver-Operated Controls Including the Identification of Controls, Tell-Tales and Indicators;

19B. UN ECE Regulation 61 Uniform Provisions Concerning the Approval of Commercial Vehicles With Regard to Their External Projections Forward of the Cab’s Rear Panel;

19C. UN ECE Regulation 64 Uniform Provisions Concerning the Approval of Vehicles Equipped With Temporary-Use Spare Wheel/Tyres;”;

(i) by inserting after paragraph 23 the following paragraph:

“23A. UN ECE Regulation 77 Uniform Provisions Concerning the Approval of Parking Lamps for Power-Driven Vehicles;”;

(j) by inserting after paragraph 27 the following paragraph:

(a) Vehicles With Regard to Limitation of Their Maximum Speed or Their Adjustable Speed Limitation Function;

(b) Vehicles With Regard to the Installation of a Speed Limitation Device (SLD) or Adjustable Speed Limitation Device (ASLD) of an Approved Type;

(c) Speed Limitation Device (SLD) and Adjustable Speed Limitation Device (ASLD);”;

(k) by inserting after paragraph 28 the following paragraph:

“28A. UN ECE Regulation 91 Uniform Provisions Concerning the Approval of Side-Marker Lamps for Motor Vehicles and Their Trailers;”;

(l) by inserting after paragraph 32 the following paragraph:

“32A. UN ECE Regulation 101 Uniform Provisions Concerning the Approval of Passenger Cars Powered by an Internal Combustion Engine Only, or Powered by a Hybrid Electric Power Train With Regard to the Measurement of the Emission of Carbon Dioxide and

Fuel Consumption and/or the Measurement of Electric Energy Consumption and Electric Range, and of Categories M1 and N1 Vehicles Powered by an Electric Power Train Only With Regard to the Measurement of Electric Energy Consumption and Electric Range;”;

(m) in paragraph 35, by substituting for the full stop at the end of the paragraph a semi colon; and

(n) by inserting after paragraph 35 the following paragraphs:

“36. UN ECE Regulation 117 Uniform Provisions Concerning the Approval of Tyres With Regard to Rolling Sound Emissions;

37. UN ECE Regulation 119 Uniform Provisions Concerning the Approval of Cornering Lamps for Power-Driven Vehicles; and

38. UN ECE Regulation 121 Uniform Provisions Concerning the Approval of Vehicles With Regard to the Location and Identification of Hand Controls, Tell-Tales and Indicators.”.
