WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKERS' COMPENSATION SCHEME)
(INSURANCE) (AMENDMENT) (NO. 2) ORDER 2013

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [*Act 273*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) (No. 2) Order 2013**.

(2) This Order comes into operation on 8 March 2013.

Amendment of Schedule

2. The Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U (A) 45/2005*] is amended in the Schedule—

(a) by substituting for the words "Oriental Capital Assurance Berhad" the words "Tune Insurance Malaysia Berhad"; and

(b) by deleting the words "Mui Continental Insurance Berhad".
