LABUAN LIMITED PARTNERSHIPS AND LIMITED LIABILITY PARTNERSHIPS ACT 2010

LABUAN LIMITED PARTNERSHIPS AND LIMITED LIABILITY PARTNERSHIPS (AMENDMENT)
REGULATIONS 2013

IN exercise of the powers conferred by subsection 89(1) of the Labuan Limited Partnerships and Limited Liability Partnerships Act 2010 [*Act 707*], the Minister, on the recommendation of the Authority, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Labuan Limited Partnerships and Limited Liability Partnerships (Amendment) Regulations 2013**.

(2) These Regulations come into operation on 1 April 2013.

Substitution of Third Schedule

2. The Labuan Limited Partnerships and Limited Liability Partnerships Regulations 2010 [*P.U. (A) 419/2010*] are amended by substituting for the Third Schedule the following Schedule:
