(v) in relation to item 3(25)(a) in column (3) by substituting for the words “8516.72 000” the words “8516.50 000, 8516.60 200”;

(vi) in relation to item 3(25)(b) in column (3) by substituting for the words “8516.50 000, 8516.60 200” the words “8516.60 900”;

- (vii) in relation to item 3(26) in column (3) by substituting for the words “8414.51 200” the words “8414.51, 8414.59”;
- (viii) in relation to item 3(33) in column (3) by substituting for the words “9504.10 000” the words “9504.50 000, 9504.90 200”; and
- (ix) in relation to item 6 in column (4) by inserting the words “All countries”.
