AKTA MAHKAMAH KEHAKIMAN 1964

KAEDAH-KAEDAH MAHKAMAH PERSEKUTUAN (PINDAAN) 2013

PADA menjalankan kuasa yang diberikan oleh seksyen 17 Akta Mahkamah Kehakiman 1964 [*Akta 91*] dan dengan persetujuan Ketua Hakim Negara, Jawatankuasa Kaedah-Kaedah membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Mahkamah Persekutuan (Pindaan) 2013**.

Pindaan kaedah 46

2. Kaedah-Kaedah Mahkamah Persekutuan 1995 [*P.U. (A) 376/1995*], yang disebut sebagai “Kaedah-Kaedah ibu” dalam Kaedah-Kaedah ini, dipinda dalam subkaedah 46(1) dengan menggantikan perkataan “RM500” dengan perkataan “RM1000”.

Pindaan kaedah 56

3. Subkaedah 56(1) Kaedah-Kaedah ibu dipinda dengan menggantikan perkataan “RM500” dengan perkataan “RM1000”.

Pindaan kaedah 107

4. Subkaedah 107(4) Kaedah-Kaedah ibu dipinda dengan menggantikan perkataan “RM500” dengan perkataan “RM1000”.

COURTS OF JUDICATURE ACT 1964

RULES OF THE FEDERAL COURT (AMENDMENT) 2013

IN exercise of the powers conferred by section 17 of the Courts of Judicature Act 1964 [Act 91] and with the consent of the Chief Justice, the Rules Committee makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Rules of the Federal Court (Amendment) 2013**.

(2) These Rules come into operation on 1 March 2013.

Amendment of rule 46

2. The Rules of the Federal Court 1995 [*P.U. (A) 376/1995*], which are referred to as the “principal Rules” in these Rules, are amended in subrule 46(1) by substituting for the word “RM500” the word “RM1000”.

Amendment of rule 56

3. Subrule 56(1) of the principal Rules is amended by substituting for the word “RM500” the word “RM1000”.

Amendment of rule 107

4. Subrule 107(4) of the principal Rules is amended by substituting for the word “RM500” the word “RM1000”.

Substitution of Second Schedule

5. The principal Rules are amended by substituting for the Second Schedule the following schedule:
