PERINTAH HAD LAJU KEBANGSAAN (PINDAAN) 2013

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(1) Akta Pengangkutan Jalan 1987 [Akta 333], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Kebangsaan (Pindaan) 2013**.

(2) Perintah ini mula berkuat kuasa pada 28 Februari 2013.

2. Perintah Had Laju Kebangsaan 1989 [P.U. (A) 18/1989] dipinda dalam Jadual di bawah butiran 4 dengan memotong perkataan “kecuali bahagian jalan di antara persimpangan bertingkat Simpang Ampat di kilometer 216.45 dan persimpangan bertingkat Ayer Keroh di kilometer 195.50.”.

ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (AMENDMENT) ORDER 2013

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **National Speed Limit (Amendment) Order 2013**.

(2) This Order comes into operation on 28 February 2013.

Amendment of Schedule

2. The National Speed Limit Order 1989 [P.U. (A) 18/1989] is amended in the Schedule under item 4 by deleting the words “excluding that part of the road between Simpang Ampat interchange at kilometre 216.45 and Ayer Keroh interchange at kilometre 195.50.”.
