PERINTAH KUMPULAN WANG SIMPANAN PEKERJA
(TAMBAHAN DAN UBAHSUAIAN MAKSUD PENGELUARAN DI BAWAH
SUBSEKSYEN 54(6)) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 54(7) Akta Kumpulan Wang Simpanan Pekerja 1991 [*Akta 452*], Menteri, setelah berunding dengan Lembaga, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kumpulan Wang Simpanan Pekerja (Tambahan dan Ubahsuaian Maksud Pengeluaran di bawah Subseksyen 54(6)) 2012**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2013.

Tambahan dan ubahsuaian maksud pengeluaran di bawah subseksyen 54(6)

2. Subseksyen 54(6) Akta ditambah dan diubahsuai dengan memasukkan selepas perenggan (*g*) perenggan yang berikut:

“ (*ga*) ahli Kumpulan Wang itu yang beragama Islam telah menerima surat tawaran daripada Lembaga Tabung Haji untuk menunaikan haji dan memerlukan pembiayaan bagi menampung kos menunaikan haji;”.

EMPLOYEES PROVIDENT FUND ACT 1991

EMPLOYEES PROVIDENT FUND (ADDITION AND MODIFICATION TO THE PURPOSES
FOR WITHDRAWAL UNDER SUBSECTION 54(6)) ORDER 2012

IN exercise of the powers conferred by subsection 54(7) of the Employees Provident Fund Act 1991 [*Act 452*], the Minister, after consulting the Board, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Employees Provident Fund (Addition and Modification to the Purposes for Withdrawal under Subsection 54(6)) Order 2012**.

(2) This Order comes into operation on 1 January 2013.

Addition and modification to the purposes for withdrawal under subsection 54(6)

2. Subsection 54(6) of the Act is added to and modified by inserting after paragraph (*g*) the following paragraph:

“ (*ga*) the muslim member of the Fund has received the letter of offer from Lembaga Tabung Haji to perform the *haj* and requires financing for the cost of performing the *haj*”.
