CAPITAL MARKETS AND SERVICES (NON-APPLICATION OF DIVISION 5 OF PART VI)
(BUSINESS TRUST) ORDER 2012

IN exercise of the powers conferred by subsection 315(1) of the Capital Markets and Services Act 2007 [Act 671], the Minister, on the recommendation of the Commission, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Capital Markets and Services (Non-application of Division 5 of Part VI) (Business Trust) Order 2012**.

(2) This Order comes into operation on 28 December 2012.

Non-application of Division 5 of Part VI of the Act

2. Division 5 of Part VI of the Act shall not apply to a business trust.
