PADA menjalankan kuasa yang diberikan oleh subseksyen 4(2) Akta Pegawai-Pegawai Diplomat dan Konsul (Sumpah dan Fi) 1959 [*Akta 348*], Yang di-Pertuan Agong membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pegawai-Pegawai Diplomat dan Konsul (Sumpah dan Fi) (Peremitan Fi) 2012**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2013.

Peremitan fi

2. Fi bagi Pasport Malaysia dibayar di bawah Perintah Pegawai-Pegawai Diplomat dan Konsul (Fi) (No. 3) 1962 [*F.L.N. 239/62*] diremitkan —

(a) bagi subperenggan A(i), lima puluh peratus berkenaan dengan orang yang berumur 60 tahun dan ke atas; dan

(b) bagi subperenggan A(iii), dua puluh peratus berkenaan dengan —

(i) orang yang berumur 60 tahun dan ke atas; dan

(ii) kanak-kanak berumur 12 tahun dan ke bawah.

DIPLOMATIC AND CONSULAR OFFICERS (OATHS AND FEES) ACT 1959

DIPLOMATIC AND CONSULAR OFFICERS (OATHS AND FEES) (REMISSION OF FEES)
REGULATIONS 2012

IN exercise of the powers conferred by subsection 4(2) of the Diplomatic and Consular Officers (Oaths and Fees) Act 1959 [*Act 348*], the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Diplomatic and Consular Officers (Oaths and Fees) (Remission of Fees) Regulations 2012**.

(2) These Regulations come into operation on 1 January 2013.

Remission of fees

2. The fees for Malaysia Passport payable under the Diplomatic and Consular Officers (Fees) (No. 3) Order 1962 [*F.L.N. 239/62*] is remitted—

(a) for subparagraph A(i), fifty percent in respect of persons of the age of 60 years and above; and

(b) for subparagraph A(iii), twenty percent in respect of—

(i) persons of the age of 60 years and above; and

(ii) children of the age of 12 years and below.
