“(i) Malaysia Passport (valid RM300.00;
for 5 years) except for
children of the age of 12
years and below and
students of the age of 21
years and below studying
abroad

- (ii) Malaysia Passport (valid for 5 years) for children of the age of 12 years and below and students of the age of 21 years and below studying abroad RM150.00;
- (iii) Malaysia Passport (valid for 2 years) RM100.00”; dan

(b) dengan memotong butiran (v).

DIPLOMATIC AND CONSULAR OFFICERS (OATHS AND FEES) (FEES) (NO. 3)
(AMENDMENT) ORDER 2012

IN exercise of the powers conferred by subsection 4(1) of the Diplomatic and Consular Officers (Oaths and Fees) Act 1959 [Act 348], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Diplomatic and Consular Officers (Oaths and Fees) (Fees) (No. 3) (Amendment) Order 2012**.

(2) This Order comes into operation on 1 January 2013.

Amendment of Schedule

2. The Schedule to the Diplomatic and Consular Officers (Fees) (No. 3) Order 1962 [F.L.N. 239/62] is amended in paragraph A—

(a) by substituting for items (i), (ii) and (iii) the following items:

“(i) Malaysia Passport (valid for RM300.00;
5 years) except for children
of the age of 12 years and
below and students of the
age of 21 years and below
studying abroad

- (ii) Malaysia Passport (valid for 5 years) for children of the age of 12 years and below and students of the age of 21 years and below studying abroad RM150.00;
- (iii) Malaysia Passport (valid for 2 years) RM100.00”; and

(b) by deleting item (v).
