AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN (PINDAAN) (NO. 4) 2012

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (Pindaan) (No. 4) 2012**.

(2) Subperenggan 2(*a*) dan subsubperenggan 2(*b*)(ii) disifatkan telah mula berkuat kuasa pada 20 November 2012.

(3) Subsubperenggan 2(*b*)(i) disifatkan telah mula berkuat kuasa pada 15 November 2012.

**Pindaan Jadual**

2. Jadual kepada Perintah Menteri-Menteri Kerajaan Persekutuan 2009 [*P.U. (A) 222/2009*] dipinda—

(*a*) berkenaan dengan Kementerian Tenaga, Teknologi Hijau dan Air dengan memotong perkataan “Puan Noriah binti Kasnon” dalam ruang “*Nama*” dan perkataan “Timbalan Menteri Tenaga, Teknologi Hijau dan Air” yang terdapat bersetentangan dengannya dalam ruang “*Gelaran dan Nama Jawatan*”; dan

(*b*) berkenaan dengan Kementerian Pembangunan Wanita, Keluarga dan Masyarakat—

(i) dengan memotong perkataan “Senator Puan Heng Seai Kie” dalam ruang “*Nama*” dan perkataan “Timbalan Menteri Pembangunan

Wanita, Keluarga dan Masyarakat” dalam ruang “*Gelaran dan Nama Jawatan*”; dan

- (ii) dengan memasukkan dalam ruang “*Nama*” dan “*Gelaran dan Nama Jawatan*” selepas perkataan “Dato’ Sri Mohd. Najib bin Tun Haji Abdul Razak” dan “Menteri Pembangunan Wanita, Keluarga dan Masyarakat” masing-masing perkataan yang berikut:

“Dato’ Noriah binti Kasnon	Timbalan Menteri Pembangunan Wanita, Keluarga dan Masyarakat”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) (NO. 4) ORDER 2012

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) (No. 4) Order 2012**.

(2) Subparagraph 2(a) and subparagraph 2(b)(ii) are deemed to have come into operation on 20 November 2012.

(3) Subsubparagraph 2(b)(i) is deemed to have come into operation on 15 November 2012.

**Amendment of Schedule**

2. The Schedule to the Ministers of the Federal Government Order 2009 [P.U. (A) 222/2009] is amended—

(a) in respect of the Ministry of Energy, Green Technology and Water by deleting the words “Puan Noriah binti Kasnon” in the “*Persons*” column and the words “Deputy Minister of Energy, Green Technology and Water” against it in the “*Styles and Titles*” column; and

(b) in respect of the Ministry of Women, Family and Community Development—

(i) by deleting the words “Senator Puan Heng Seai Kie” in the “*Persons*” column and the words “Deputy Minister of Women, Family and Community Development” in the “*Styles and Titles*” columns; and

- (ii) by inserting in the “*Persons*” and “*Styles and Titles*” columns after the words “Dato’ Sri Mohd. Najib bin Tun Haji Abdul Razak” and “Minister of Women, Family and Community Development” respectively, the following words:

“Dato’ Noriah binti Kasnon	Deputy Minister of Women, Family and Community Development”.
