AKTA YAYASAN LABUAN 2010

PERATURAN-PERATURAN YAYASAN LABUAN (PINDAAN) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 80(1) Akta Yayasan Labuan 2010 [Akta 706], Menteri, atas syor Lembaga, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Yayasan Labuan (Pindaan) 2026**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2026.

Penggantian Jadual Ketiga

LABUAN FOUNDATIONS ACT 2010

LABUAN FOUNDATIONS (AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by subsection 80(1) of the Labuan Foundations Act 2010 [*Act 706*], the Minister, on the recommendation of the Authority, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Labuan Foundations (Amendment) Regulations 2026**.

(2) These Regulations come into operation on 1 July 2026.

Substitution of Third Schedule

2. The Labuan Foundations Regulations 2010 [*P.U. (A) 418/2010*] are amended by substituting for the Third Schedule the following schedule:
