## AKTA AMANAH LABUAN 1996

## PERATURAN-PERATURAN AMANAH LABUAN (PINDAAN) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 57(1) Akta Amanah Labuan 1996 [Akta 554], Menteri, atas syor Lembaga, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Amanah Labuan (Pindaan) 2026**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2026.

## LABUAN TRUSTS ACT 1996

## LABUAN TRUSTS (AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by subsection 57(1) of the Labuan Trusts Act 1996 [Act 554], the Minister, on recommendation of the Authority, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Labuan Trusts (Amendment) Regulations 2026**.

(2) These Regulations come into operation on 1 July 2026.

**Substitution of Third Schedule**

2. The Labuan Trusts Regulations 2010 [P.U. (A) 415/2010] are amended by substituting for the Third Schedule the following schedule:
