LABUAN LIMITED PARTNERSHIPS AND LIMITED LIABILITY PARTNERSHIPS
(AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by subsection 89(1) of the Labuan Limited Partnerships and Limited Liability Partnerships Act 2010 [*Act 707*], the Minister, on the recommendation of the Authority, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Labuan Limited Partnerships and Limited Liability Partnerships (Amendment) Regulations 2026**.

(2) These Regulations come into operation on 1 July 2026.

Substitution of Third Schedule

2. The Labuan Limited Partnerships and Limited Liability Partnerships Regulations 2010 [*P.U. (A) 419/2010*] are amended by substituting for the Third Schedule the following schedule:
