AKTA EKSAIS 1976

PERINTAH DUTI EKSAIS (PENGECUALIAN) (PINDAAN) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(1) Akta Eksais 1976 [*Akta 176*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Eksais (Pengecualian) (Pindaan) 2012**.

(2) Perintah ini mula berkuat kuasa pada 16 Oktober 2012.

Pindaan Jadual

2. Perintah Duti Eksais (Pengecualian) 1977 [*P.U. (A) 151/1977*] dipinda dalam Bahagian I Jadual berhubung dengan butiran 24—

(a) dalam ruang (2), dengan memasukkan selepas perkataan “cab licence” perkataan “, airport taxi cab”;

(b) dalam ruang (4)—

(i) dengan memasukkan selepas perkataan “taxi cab” di mana-mana jua terdapat perkataan “, airport taxi cab”;

(ii) dengan menggantikan perkataan “Commercial Vehicles Licensing Board” di mana-mana jua terdapat dengan perkataan “Land Public Transport Commission”;

(iii) dengan menggantikan perkataan “Commercial Vehicles Licensing Board Act 1987 [*Act 334*]” di mana-mana jua terdapat dengan perkataan “Land Public Transport Act 2010 [*Act 715*]”; dan

(iv) dengan memasukkan selepas subbutiran (viii) subbutiran yang berikut:

“(ix) that the motor vehicle is purchased from the excise duty unpaid stock.”.

EXCISE ACT 1976

EXCISE DUTIES (EXEMPTION) (AMENDMENT) ORDER 2012

IN exercise of the powers conferred by subsection 11(1) of the Excise Act 1976 [Act 176], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Excise Duties (Exemption) (Amendment) Order 2012**.

(2) This Order comes into operation on 16 October 2012.

Amendment of Schedule

2. The Excise Duties (Exemption) Order 1977 [*P.U. (A) 151/1977*] is amended in Part I of the Schedule in relation to item 24—

(a) in column (2), by inserting after the words “cab licence” the words
“; airport taxi cab”;

(b) in column (4)—

(i) by inserting after the words “taxi cab” wherever appearing the words
“; airport taxi cab”;

(ii) by substituting for the words “Commercial Vehicles Licensing Board” wherever appearing the words “Land Public Transport Commission”;

(iii) by substituting for the words “Commercial Vehicles Licensing Board Act 1987 [*Act 334*]” wherever appearing the words
“Land Public Transport Act 2010 [*Act 715*]”; and

(iv) by inserting after subitem (viii) the following subitem:

“(ix) that the motor vehicle is purchased from the excise duty unpaid stock.”.
