AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) 2012**.

(2) Perintah ini mula berkuat kuasa pada 19 September 2012.

Pindaan Jadual Pertama

2. Perintah Kastam (Larangan Mengenai Eksport) 2008 [P.U. (A) 87/2008], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dalam Jadual Pertama dengan memotong butiran 2 dan butir-butir yang berhubungan dengan butiran itu.

Pindaan Jadual Kedua

3. Jadual Kedua Perintah ibu dipinda dengan memasukkan selepas butiran 47 dan butir-butir yang berhubungan dengan butiran itu butiran yang berikut:

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) ORDER 2012

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) Order 2012**.

(2) This Order comes into operation on 19 September 2012.

Amendment of First Schedule

2. The Customs (Prohibition of Exports) Order 2008 [*P.U. (A) 87/2008*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule by deleting item 2 and the particulars relating to the item.

Amendment of Second Schedule

3. The Second Schedule of the principal Order is amended by inserting after item 47 and the particulars relating to the item the following item:
