ENTERTAINMENTS DUTY (EXEMPTION) (NO. 4) ORDER 2012

IN exercise of the powers conferred by paragraph 12(1)(b) of the Entertainments Duty Act 1953 [*Act 103*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Entertainments Duty (Exemption) (No. 4) Order 2012**.

**Exemption**

2. The admission ticket for the Michael Learns to Rock World Tour Live in Malaysia 2011 show which was held at Plenary Hall KLCC, Kuala Lumpur on 22 April until 2 May 2011 is exempted from entertainments duty.
