(a) dengan memasukkan selepas koma bernokhtah di hujung perenggan
(b) perkataan “atau”;

(b) dengan menggantikan perkataan “; atau” di hujung perenggan (c)
dengan nokhtah; dan

(c) dengan memotong perenggan (d).

LABOUR ORDINANCE OF SABAH

LABOUR (TERMINATION AND LAY-OFF BENEFITS) (SABAH) (AMENDMENT) RULES
2012

IN exercise of the powers conferred by paragraph 130o(2)(k) of the Labour Ordinance of Sabah [*Sabah Cap. 67*], the Minister after consultation with the State Authority, makes the following rules:

Citation

1. These rules may be cited as the **Labour (Termination and Lay-Off Benefits) (Sabah) (Amendment) Rules 2012**.

Amendment to rule 4

2. The Labour (Termination and Lay-Off Benefits) (Sabah) Rules 2008 [*P.U. (A)159/2008*] are amended in subrule 4(1) —

(a) by inserting after the semicolon at the end of paragraph (b) the word “or”;

(b) by substituting for the words “; or” at the end of paragraph (c) a full stop;
and

(c) by deleting paragraph (d).
