AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 5) 2012

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 5) 2012**.

(2) Perintah ini mula berkuat kuasa pada 10 Ogos 2012.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala "Negeri Pahang Darul Makmur"

(a) dengan memasukkan selepas butiran 40 butiran yang berikut:

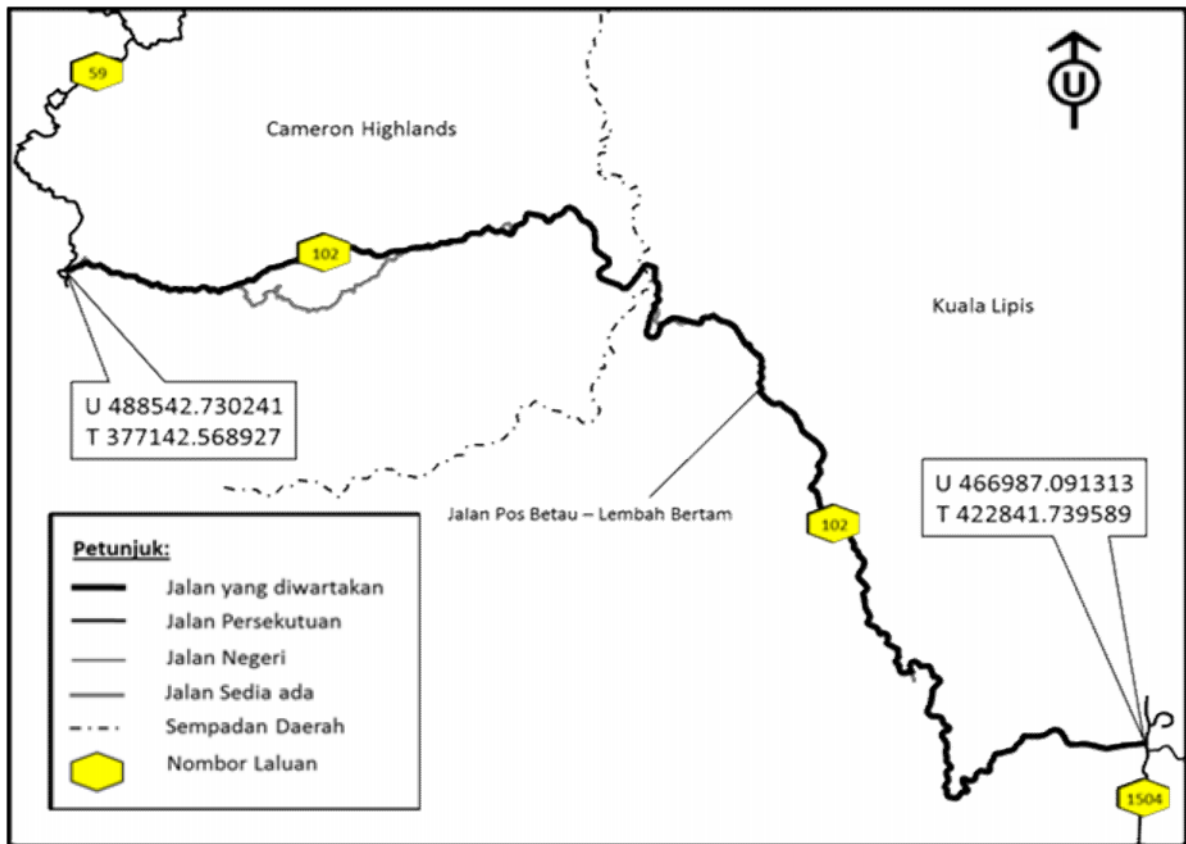
"41. *(Laluan 102): Jalan Pos Betau – Lembah Bertam*

Dari persimpangannya dengan Laluan 1504 di koordinat Utara (U) 466987.091313, Timur (T) 422841.739589 dan berakhir di persimpangan dengan Laluan 59 di koordinat Utara (U) 488542.730241, Timur (T) 377142.568927 sebagaimana yang ditunjukkan dalam Peta 20: Negeri Pahang.

Jarak sepanjang 79.23 km."; dan

(b) dengan memasukkan selepas “PETA 19: NEGERI PAHANG” peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 5) ORDER 2012

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Negeri Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 5) Order 2012**.

(2) This Order comes into operation on 10 August 2012.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of "Negeri Pahang Darul Makmur"

(a) by inserting after item 40 the following item:

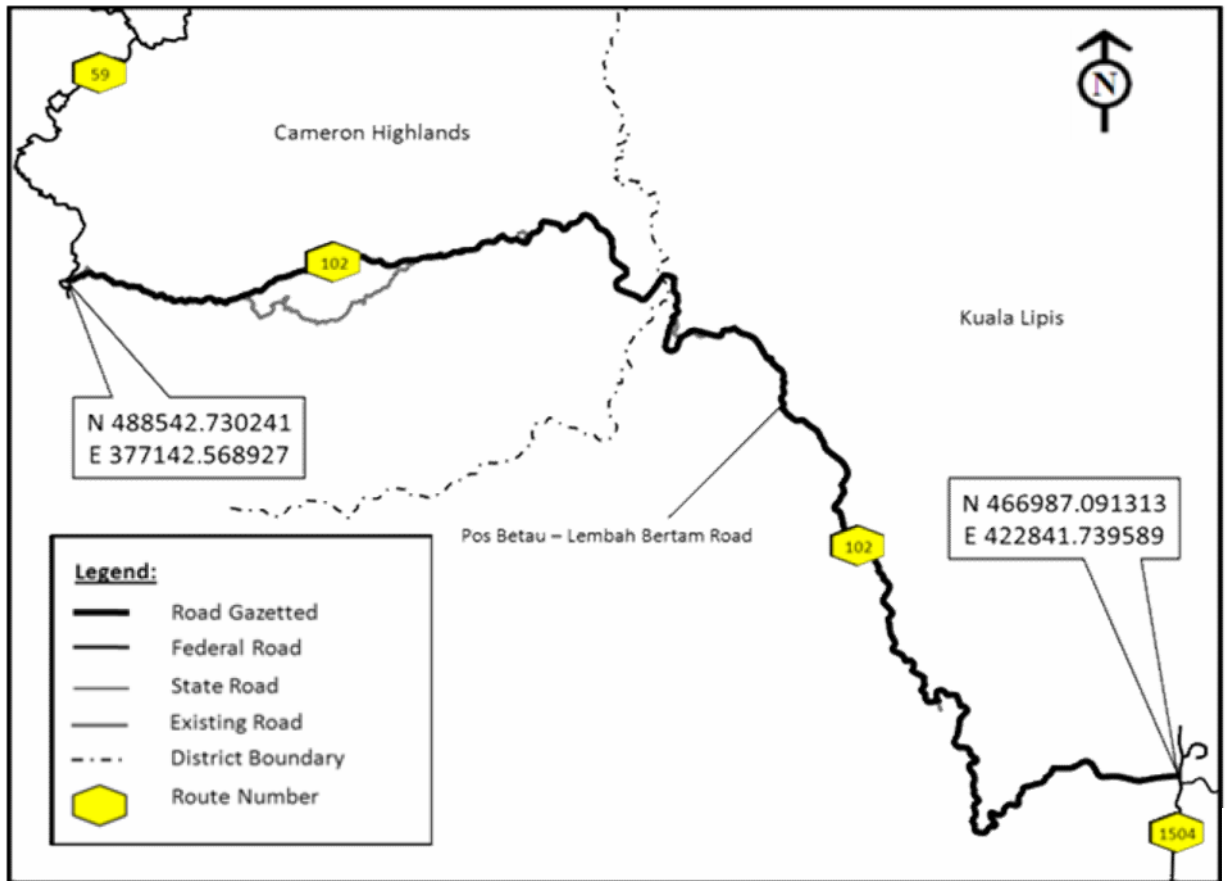
"41. *(Route 102): Pos Betau – Lembah Bertam Road*

From its junction with Route 1504 at coordinates North (N) 466987.091313, East (E) 422841.739589 and ending at junction with Route 59 at coordinates North (N) 488542.730241, East (E) 377142.568927 as shown on Map 20: Negeri Pahang.

A distance of 79.23 km."; and

(b) by inserting after "MAP 19: NEGERI PAHANG" the following map:
