LOANS GUARANTEE (BODIES CORPORATE) ACT 1965

LOANS GUARANTEE (DECLARATION OF BODIES CORPORATE)
(PULAU MELAKA LTD.) ORDER 2012

IN exercise of the powers conferred by section 3 of the Loans Guarantee (Bodies Corporate) Act 1965 [*Act 96*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Loans Guarantee (Declaration of Bodies Corporate) (Pulau Melaka Ltd.) Order 2012**.

(2) This Order comes into operation on 25 July 2012.

Declaration of application of the Act

2. The body corporate known as Pulau Melaka Ltd. is declared to be a body corporate to which the Act applies.
