PADA menjalankan kuasa yang diberikan oleh perenggan 16(2)(j) Akta Pendaftaran Perniagaan 1956 [*Akta 197*], Menteri membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Pendaftaran Perniagaan (Pengurangan Fi untuk Pendaftaran Baru dan Pembaharuan Pendaftaran) 2012**.

(2) Kaedah-Kaedah ini berkuat kuasa mulai 1 Jun 2012 hingga 31 Disember 2012.

Pengurangan fi untuk pendaftaran baru dan pembaharuan perniagaan

2. Fi yang ditetapkan di bawah kaedah 19 dan Jadual Kedua Kaedah-Kaedah Pendaftaran Perniagaan 1957 [*L.N. 282/1957*] bagi maksud seksyen 5 dan 5A Akta dikurangkan kepada lima puluh ringgit sebagai bayaran fi sekaligus bagi tempoh lima tahun.

REGISTRATION OF BUSINESSES ACT 1956

REGISTRATION OF BUSINESSES (REDUCTION OF FEES FOR NEW REGISTRATION AND
RENEWAL OF REGISTRATION) RULES 2012

IN exercise of the powers conferred by paragraph 16(2)(j) of the Registration of Businesses Act 1965 [*Act 197*], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Registration of Businesses (Reduction of Fees for New Registration and Renewal of Registration) Rules 2012**.

(2) These Rules have effect from 1 June 2012 to 31 December 2012.

Reduction of fees for new registration and renewal of businesses

2. The fees prescribed under rule 19 and the Second Schedule of the Registration of Businesses Rules 1957 [*L.N. 282/1957*] for the purposes of sections 5 and 5A of the Act is reduced to fifty ringgit as a one-off payment fee for the period of five years.
