AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 3) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 3) 2012**.

(2) Perintah ini mula berkuat kuasa pada 26 Jun 2012.

Pindaan Jadual

2. Perintah Duti Kastam (Pengecualian) 1988 [*P.U. (A) 410/1988*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 126, dalam ruang (2) dengan menggantikan perenggan (vi) dengan perenggan yang berikut:

“(vi) Boustead Penang Shipyard Sdn. Bhd. (dahulunya dikenali sebagai Penang Shipbuilding & Construction Sdn. Bhd.);”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 3) ORDER 2012

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 3) Order 2012**.

(2) This Order comes into operation on 26 June 2012.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 1988 [*P.U. (A) 410/1988*] is amended in Part I of the Schedule, in relation to item 126, in column (2) by substituting for paragraph (vi) the following paragraph:

“(vi) Boustead Penang Shipyard Sdn. Bhd. (formerly known as Penang Shipbuilding & Construction Sdn. Bhd.);”.
