PERATURAN-PERATURAN PILIHAN RAYA (PENJALANAN PILIHAN RAYA)
(PINDAAN) (NO. 3) 2012

PADA menjalankan kuasa yang diberikan oleh seksyen 16 Akta Pilihan Raya 1958 [Akta 19], Suruhanjaya Pilihan Raya, dengan kelulusan Yang di-Pertuan Agong, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pilihan Raya (Penjalanan Pilihan Raya) (Pindaan) (No. 3) 2012**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 25 Jun 2012.

2. Peraturan-Peraturan Pilihan Raya (Penjalanan Pilihan Raya) 1981 [P.U. (A) 386/1981] dipinda dalam subperaturan 19A(2) dalam teks bahasa kebangsaan dengan memasukkan sebelum perkataan "hendaklah enggan" perkataan "atau mana-mana orang yang bertindak di bawah kuasanya".

ELECTIONS (CONDUCT OF ELECTIONS) (AMENDMENT) (NO. 3)
REGULATIONS 2012

IN exercise of the powers conferred by section 16 of the Elections Act 1958 [*Act 19*], the Election Commission, with the approval of the Yang di-Pertuan Agong, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Elections (Conduct of Elections) (Amendment) (No. 3) Regulations 2012**.

(2) These Regulations come into operation on 25 June 2012.

Amendment of regulation 19A

2. The Elections (Conduct of Elections) Regulations 1981 [*P.U. (A) 386/1981*] are amended in subregulation 19A(2) in the national language text by inserting before the words "hendaklah enggan" the words "atau mana-mana orang yang bertindak di bawah kuasanya".
