PERINTAH KASTAM (LARANGAN MENGENAI IMPORT)(PINDAAN)(NO. 2) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import)(Pindaan)(No. 2) 2012**.

(2) Perintah ini mula berkuat kuasa pada 15 Jun 2012.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS)(AMENDMENT)(NO. 2) ORDER 2012

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment)(No. 2) Order 2012**.

(2) This Order comes into operation on 15 June 2012.

Amendment of Second Schedule

2. The Customs (Prohibition of Imports) Order 2008 [*P.U. (A) 86/2008*] is amended in Part II of the Second Schedule, by inserting after item 42 and the particulars relating to the item the following item:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Heading/ Subheading</i>	(4) <i>Country</i>	(5) <i>Manner of Import</i>
" 43.	Flat-rolled products of other alloy steel, of a width of 600 mm or more	72.25	All countries	Ministry of International Trade and Industry .".
