PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 3) 2012

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 3) 2012**.

(2) Perintah ini mula berkuat kuasa pada 25 Mei 2012.

Pindaan Jadual Ketiga

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Ketiga di bawah kepala "Negeri Pahang Darul Makmur"

(a) dengan memasukkan selepas butiran 16 butiran yang berikut:

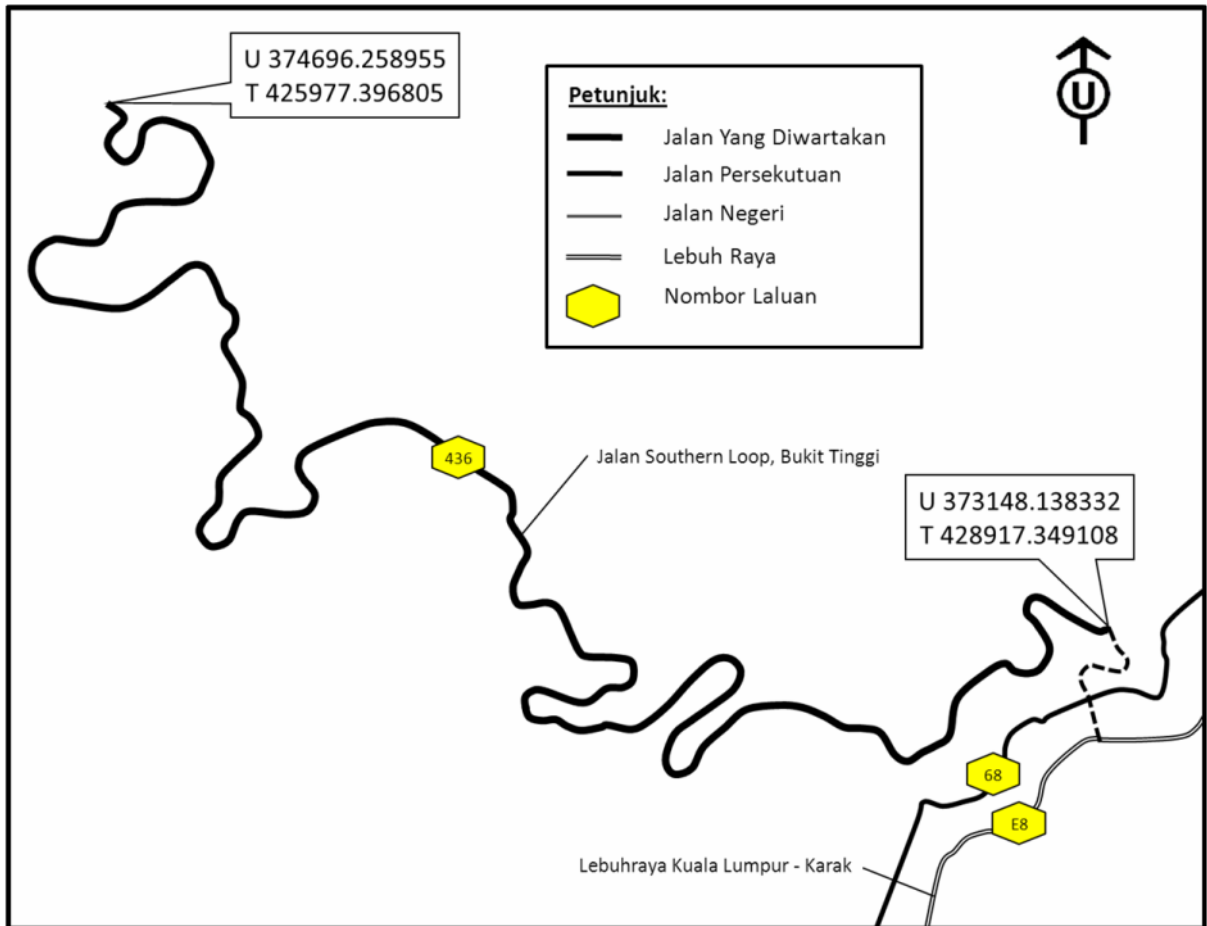
"(17). *(Laluan 436): Jalan Sothern Loop, Bukit Tinggi*

Dari persimpangan jalan di koordinat U 373148.138332, T 428917.349108 dan berakhir di persimpangan di koordinat U 374696.258955, T 425977.396805 sebagaimana yang ditunjukkan dalam Peta 2: Jalan-Jalan Persekutuan Negeri Pahang.

Jarak sepanjang 8.40 km."; dan

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 3) ORDER 2012

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Negeri Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 3) Order 2012**.

(2) This Order comes into operation on 25 May 2012.

Amendment of Third Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the Third Schedule under the heading of "Negeri Pahang Darul Makmur"

(a) by inserting after item 16 the following item:

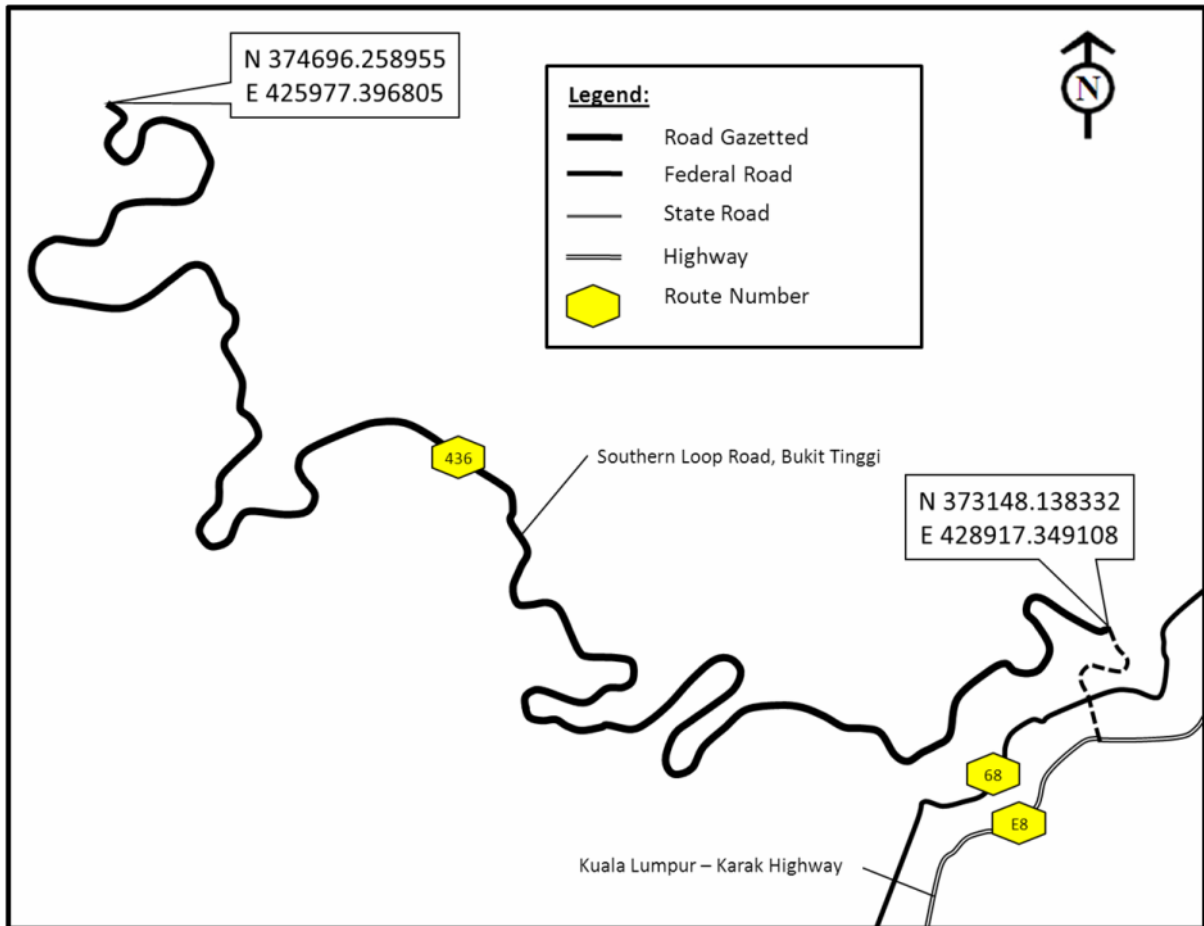
"(17). (Route 436): Sothern Loop Road, Bukit Tinggi

From junction at coordinates N 373148.138332, E 428917.349108 and ending at junction at coordinates N 374696.258955, E 425977.396805 as shown on Map 2: Federal Roads of Negeri Pahang.

A distance of 8.40 km."; and

(b) by inserting after "MAP: FEDERAL ROADS OF NEGERI PAHANG" the following map:
