LOANS GUARANTEE (DECLARATION OF BODIES CORPORATE)  
(1MDB REAL ESTATE SENDIRIAN BERHAD) ORDER 2012

IN exercise of the powers conferred by section 3 of the Loans Guarantee (Bodies Corporate) Act 1965 [*Act 96*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Loans Guarantee (Declaration of Bodies Corporate) (1MDB Real Estate Sendirian Berhad) 2012**.

(2) This Order comes into operation on 16 May 2012.

**Declaration of application of the Act**

2. The body corporate known as 1MDB Real Estate Sendirian Berhad (1MDBRE) is declared to be a body corporate to which the Act applies.
