PERINTAH INSURANS (PENGECUALIAN) 2012

PADA menjalankan kuasa yang diberikan oleh seksyen 198 Akta Insurans 1996 [Akta 553], Menteri, setelah menimbangkan bahawa perkara yang akan dikecualikan adalah selaras dengan maksud Akta ini dan demi kepentingan awam, membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Insurans (Pengecualian) 2012**.

Pengecualian daripada perenggan 71(1)(a) Akta

2. (1) ING Insurance Berhad, suatu penanggung insurans berlesen di bawah Akta yang mempunyai alamat berdaftar di Menara ING, 84, Jalan Raja Chulan, 50927 Kuala Lumpur dikecualikan daripada perenggan 71(1)(a) Akta berhubung dengan pelantikan Bruce Murray Hodges (Nombor Pasport: BA723733) yang dibuat olehnya sebagai ketua pegawai eksekutif dan pengarah eksekutif ING Insurance Berhad.

- (2) ING Management Holdings (Malaysia) Sdn Bhd, pengawal ING Insurance Berhad yang mempunyai alamat berdaftar di ING Management Holdings (Malaysia) Sdn Bhd, Menara ING, 84, Jalan Raja Chulan, 50927 Kuala Lumpur dikecualikan daripada perenggan 71(1)(a) Akta berhubung dengan pelantikan Bruce Murray Hodges (Nombor Pasport: BA723733) yang dibuat olehnya sebagai pengarah bukan eksekutif bukan bebas ING Management Holdings (Malaysia) Sdn Bhd.

- (3) Bruce Murray Hodges (Nombor Pasport: BA723733) dikecualikan daripada perenggan 71(1)(a) Akta berhubung dengan—

- (a) penerimaan pelantikannya sebagai ketua pegawai eksekutif dan pengarah eksekutif ING Insurance Berhad; dan

- (b) penerimaan pelantikannya sebagai pengarah bukan eksekutif bukan bebas ING Management Holdings (Malaysia) Sdn Bhd.

INSURANCE ACT 1996

INSURANCE (EXEMPTION) ORDER 2012

IN exercise of the powers conferred by section 198 of the Insurance Act 1996 [Act 553], the Minister, after having considered that the matters to be exempted are consistent with the purposes of the Act and are in the interest of the public, makes the following order:

Citation

1. This order may be cited as the **Insurance (Exemption) Order 2012**.

Exemption from paragraph 71(1)(a) of the Act

2. (1) ING Insurance Berhad, a licensed insurer under the Act having its registered office at Menara ING, 84, Jalan Raja Chulan, 50927 Kuala Lumpur is exempted from paragraph 71(1)(a) of the Act relating to the appointment by it of Bruce Murray Hodges (Passport Number: BA723733) as the chief executive officer and executive director of ING Insurance Berhad.

- (2) ING Management Holdings (Malaysia) Sdn Bhd, the controller of ING Insurance Berhad having its registered office at ING Management Holdings (Malaysia) Sdn Bhd, Menara ING, 84, Jalan Raja Chulan, 50927 Kuala Lumpur is exempted from paragraph 71(1)(a) of the Act relating to the appointment by it of Bruce Murray Hodges (Passport Number: BA723733) as a non-independent non-executive director of ING Management Holdings (Malaysia) Sdn Bhd.

- (3) Bruce Murray Hodges (Passport Number: BA723733) is exempted from paragraph 71(1)(a) of the Act relating to—

- (a) the acceptance of his appointment as the chief executive officer and executive director of ING Insurance Berhad; and

- (b) the acceptance of his appointment as a non-independent non-executive director of ING Management Holdings (Malaysia) Sdn Bhd.
