FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 2) ORDER 2012

IN exercise of the power conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister after consultation with the State Government of Johor, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 2) Order 2012**.

(2) This Order comes into operation on 1 April 2012.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule under the heading of “Negeri Johor” by deleting item 31.
