PROMOTION OF INVESTMENTS ACT 1986

PROMOTION OF INVESTMENTS (PROMOTED ACTIVITIES AND PROMOTED PRODUCTS
FOR SMALL SCALE COMPANIES) ORDER 2012

IN exercise of the powers conferred by section 4 of the Promotion of Investments Act 1986 [*Act 327*], the Minister, with the concurrence of the Minister of Finance, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Promotion of Investments (Promoted Activities and Promoted Products for Small Scale Companies) Order 2012**.

(2) This Order comes into operation on 2 March 2012.

Promoted activities and promoted products for small scale companies

2. The activities and products listed in the First Schedule are determined to be promoted activities and promoted products for small scale companies.

Revocation

3. The Orders as set out in the Second Schedule are revoked.
