AKTA PENGANGKUTAN JALAN 1987

PERINTAH HAD LAJU KEBANGSAAN (PEMBERHENTIAN SEMENTARA) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(1) Akta Pengangkutan Jalan 1987 [Akta 333], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Kebangsaan (Pemberhentian Sementara) 2012**.

(2) Perintah ini berkuat kuasa mulai 16 Januari 2012 hingga 30 Januari 2012.

**Pemberhentian Sementara**

2. (1) Subperenggan 2(1) Perintah Had Laju Kebangsaan 1989 [P.U. (A) 18/1989] yang memperuntukkan had laju 90 kilometer sejam bagi semua jalan di Malaysia, selain jalan yang diperihalkan dalam Jadual kepada Perintah Had Laju Kebangsaan 1989, hendaklah terhenti berkuat kuasa bagi tempoh mulai 16 Januari 2012 hingga 30 Januari 2012.

(2) Apabila habis tempoh Perintah ini, subperenggan 2(1) Perintah Had Laju Kebangsaan 1989 hendaklah berkuat kuasa seolah-olah Perintah ini tidak dibuat.

ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (TEMPORARY CESSATION) ORDER 2012

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **National Speed Limit (Temporary Cessation) Order 2012**.

(2) This Order has effect from 16 January 2012 to 30 January 2012.

**Temporary Cessation**

2. (1) Subparagraph 2(1) of the National Speed Limit Order 1989 [P.U. (A) 18/1989] which provides the speed limit of 90 kilometers per hour for all roads in Malaysia other than the roads described in the Schedule to the National Speed Limit Order 1989, shall cease to have effect for the period from 16 January 2012 to 30 January 2012.

(2) Upon the expiry of this Order, subparagraph 2(1) of the National Speed Limit Order 1989 shall have effect as if this Order has not been made.
