AKTA PENGANGKUTAN JALAN 1987

PERINTAH HAD LAJU TEMPATAN (JALAN PERSEKUTUAN)  
(LARANGAN MASA TERTENTU) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(2) Akta Pengangkutan Jalan 1987 [*Akta 333*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Tempatan (Jalan Persekutuan) (Larangan Masa Tertentu) 2012**.

(2) Perintah ini berkuat kuasa mulai 16 Januari 2012 hingga 30 Januari 2012.

**Larangan**

2. (1) Pemanduan kenderaan motor dengan kelajuan yang lebih daripada 80 km/j di atas semua jalan Persekutuan di Malaysia, selain jalan yang dinyatakan dalam Jadual Pertama Perintah Had Laju Tempatan (Jalan Persekutuan) (Malaysia Barat) 1992 [*P.U. (A) 462/1991*], dilarang.

(2) Larangan yang disebut dalam subperenggan (1) hendaklah terhenti berkuat kuasa apabila habis tempoh Perintah ini.

ROAD TRANSPORT ACT 1987

LOCAL SPEED LIMIT (FEDERAL ROADS) (SPECIFIED TIME PROHIBITION)  
ORDER 2012

IN exercise of the powers conferred by subsection 69(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Local Speed Limit (Federal Roads) (Specified Time Prohibition) Order 2012**.

(2) This Order has effect from 16 January 2012 to 30 January 2012.

**Prohibition**

2. (1) The driving of motor vehicles at a speed greater than 80 km/h over all Federal roads in Malaysia, other than the roads specified in the First Schedule of the Local Speed Limit (Federal Roads) (West Malaysia) Order 1992 [*P.U. (A) 462/1991*], is prohibited.

(2) The prohibition mentioned in subparagraph (1) shall cease to have effect upon the expiry of this Order.
